## CALL FOR PAPERS (ACBJ 2021 EDITION)

Awka Capital Bar Journal (ACBJ) is a professional and peer reviewed periodical of the Nigerian Bar Association Awka Branch. The current edition is targeted at a review of topical and diverse issues of law including but not limited to Landlord and Tenant law, female inheritance, Constitutional law, chieftaincy and town union matters, legal practice, management of law firms, Land Law, Intellectual Property Law, Criminal Law and Environmental law. The areas of law to be focused on in this journal are those areas of law that are recurrent in our day to day legal, political, social and economic life as legal practitioners and as it concerns those around us. The journal is also expected to carry out a comparative analysis of laws within the state and those of other states with similar issues for purposes of finding possible improvement. Publication of accepted papers is free of cost as the Bar Association will undertake payment for the editorial expenses and cost of publication. Original and quality papers are therefore welcome.

#### **Guidelines to Contributors**

#### 1. Language

The language of the manuscript must be English (British standards).

#### 2. Originality

Articles must be original and must not have been submitted for consideration and publication elsewhere. It is the responsibility of authors to ensure that the material submitted does not infringe copyright.

#### 3. Length of paper

The length of the paper should not exceed 5,000 words including tables, figures, references and appendices (if any). Articles should be typed in 1.5-line spacing (footnotes and references should appear in single line spacing) on one side of A4 paper only with wide margins. Font size "12" for the body of the paper, font size "11" for abstract and font size "10" for footnoting. Authors are to write concise and precise papers, but not at the expense of clarity and appropriate page range.

#### 4. Title Page

The Title page should include: (i) The name(s) of the author(s), (ii) A concise and informative title, (iii) The affiliation(s) and address (es) of the author(s), (iv) The e-mail address, and telephone numbers of the corresponding author.

#### 5. Abstract

Contributors shall provide an abstract of 150 to 200 words which must include the objectives of the study, methodology, findings/results, method of data collection and summary of recommendations. The abstract should not contain any undefined abbreviations or unspecified references.

#### 6. Keywords

Authors are to provide 4 to 6 keywords which can be used for indexing.

#### 7. Subdivision of the article

Authors are to divide your article into clearly defined and numbered sections. Subsections should be numbered 1, 2. (then 1.1, 1.1.1, 1.1.2), 1.2, etc). The abstract is not included in section numbering.

#### 8. References and Documentation

Author(s) are expected to adhere strictly to Nigerian Association of Law Teachers Uniform Citation and Documentation Standards accessible at www.naltng.org.

- **9.** Names of authors cited in the footnotes should start with initials and end with the surname.
- 10. Online sources should indicate the site and date of visit.
- 11. All submissions will undergo double blind peer review and plagiarism check.
