### EDITORIAL POLICY AND NOTES TO CONTRIBUTORS

The Frontline Bar Journal is a publication of the Nigerian Bar Association, Aguata Branch, Anambra State of Nigeria. The views, comments and opinions expressed in this journal by contributors are strictly those of the individual contributors and do not in any way whatsoever represent those of the Nigerian Bar Association, Aguata Branch or those of the Editorial Board.

The Journal accepts manuscripts dealing with any contemporary legal issue including but not limited to politics, security, the economy, society, constitutionalism, governance and the judiciary for editorial consideration and possible publication but takes no responsibility for any material or manuscript received but not published. Manuscripts typed in the standard format with double-line spacing and not exceeding twenty pages of the A4 paper should be sent as directed below together with a CD in Microsoft Word. Footnotes should be placed at the bottom of the pages where they appear. It is imperative that contributors use the automatic footnoting system.

All articles must be original and typed using double line spacing. One hard copy is required for assessment alongside an electronic copy sent through our email address ([barcjuba@yahoo.com](mailto:barcjuba@yahoo.com)).

The contributors should comply with the following guidelines:

1. Papers must be original and well-researched, and must not have been previously published within or outside the country.
2. Contributors must provide an abstract of not more than 250 words.
3. Contributors must state title of paper, brief personal details, phone numbers(s), e-mail (if any), and postal address, on a separate page.
4. Citations should be exclusively on footnote and should follow the following format:
  - I. Books: Author's initials followed by surname, title of the book in italics, the edition (if any), (place of publication: publisher, year of publication), page number. For example, O F Ogbuinya, *Understanding the Concept of Jurisdiction in the Nigerian Legal System*, (Enugu: Snap Press Ltd, 2008), p.22.
  - II. Chapter in Books: Author's initials followed by surname, title of article in inverted commas, editor(s), title of the book in italics, the edition (if any), (place of publication: publisher, year of publication), page number. For example, P. Nnaemeka-Agu, "Ensuring Accountability and Good Governance through the Africa Charter on Human and People's Rights" in CC Nweze and O. Nwankwo (eds.), *Current Themes in the Domestication of Human Rights Norms* (Enugu: Fourth Dimension Publishing Co., Ltd., 2003), p. 101.
  - III. Subsequent References: For exactly the same reference as the previous, use *ibid* (in italics). For exactly the same reference as in the previous footnote but from a different page, use *ibid* p.22. For subsequent reference but not immediately succeeding the current one, use *op cit*. For instance, *CJ Ubanyionwu, op cit* p.22. For a subsequent citation of a case already cited in full, use *supra* (in italics). 'Ibid', 'supra' and 'op cit.' are non-English words and as such are required to be italicized.
  - IV. Journals: Authors initials before surname, title of the article in inverted comma, volume number, (year), title of the journal in italics, and page number. For example, IU Ibe "Basic Proposal for Judiciary's Effectiveness in a Democracy, Nigeria as a Case Study" Vol. 1 No. 1 (2013), *Premier Bar Journal*, pp. 34-48.
  - V. Cases: Names of the cases (in full and in full italics), the year reported (in brackets), volume of the law report, part (in brackets), page number. For example, *Ikeme v. Ugwu* (2013)15 NWLR (Pt. 1377) 358.
  - VI. Statute: Full name of the statute followed by the year of the enactment. For example, *The Police Act, Cap.PIS, Laws of the Federation of Nigeria, 2004*.
  - VII. Web Page: Web address, date the material was accessed and time the web was visited. For example: [www.nigerianlawguru.com/n/articles/jurisprudence/JUDICIAL%20OACTIVISM.pdf](http://www.nigerianlawguru.com/n/articles/jurisprudence/JUDICIAL%20OACTIVISM.pdf) (last accessed on 11/11/2013, 12.30pm.)
5. Formatting: Type to Microsoft Word 2007 (or above) on A4 paper size '1.5' line spacing, not exceeding 20 pages with corresponding automatic footnoting (not manual please). Times New Romans, font size ' 14' on the body of the text and 10 at the footnotes.
6. Referral: All articles will be sent to one of our editors to be reviewed for accuracy and relevance. Nevertheless, contributors must do a thorough proof-reading of their works before submission.

Please note that adherence to methodology, style and formatting is very strict. Any paper falling short of the prescribed standard stands disqualified and the editorial board bears no responsibility to return any disqualified paper. If your article is accepted for publication you may be required to pay handling charges.
