CALL FOR PAPERS

The Editorial Board of Nnamdi Azikiwe University Journal of Law and Clinical Legal Education (NAUJLCLE), invites authorsto submit well researched and original papers on topical issues of law and legal education for publication in its scholarly, peer reviewed, and open access Journal. The Journal is a publication of the Department of Clinical Legal Education, Faculty of Law, Nnamdi Azikiwe University, Awka, Nigeria. The Journal considers for publication, papers on topical current issues in law, legal education as well as case and law reviews. The papers will be published in print, in addition to enjoying an online visibility.

Authors are required to comply with the Following Guidelines:

- i. Issues covered by manuscripts submitted for publication must in addition to being well-researched and original, must not offend any rule of academic integrity or copyright laws.
- ii. Manuscripts should be split into clearly defined and numbered sections and subsections and should not exceed 6,000 words (inclusive of references), while case and law reviews should not exceed 4,000 words.
- iii. Manuscripts should be typed using Microsoft Words with Times New Roman in font size 12, and a 1.5 line spacing in the body of the work, while a single line spacing of font size 10 should be used for the footnotes.
- iv. An Abstract of not more than 250 words should also be included in the manuscript. In addition, 4 to 6 keywords to be used for purposes of indexing should be provided by authors.
- v. A title page containing the full names of authors, their qualification, email addresses, telephone numbers, and institutions affiliated to (including that of corresponding authors) should be submitted as part of the manuscript.
- vi. The acceptable referencing style is the Nigerian Association of Law Teachers Uniform Citation Guideline (NALT Citation Guidelines), which is available at www.naltng.org. All the sources, including online sources, must be indicated and acknowledged by complete references.
- vii. Manuscripts submitted /received shall be subjected to a peer review process, and the Editorial Board will communicate with only authors whose manuscript are recommended for publication by independent expert assessors in the subject area and accepted by the Editorial Board.
- viii. Manuscripts should be sent as an attachment by email to naujlcle.unizik@gmail.com.
- ix. Deadline for Submission: All manuscripts must be received on or before the 31st day of October, 2024.
